Actions taken by the Substantive Change Committee between January and June 2011 to Approve the Following:

Citrus College: to offer six degree programs and five certificate programs at 50% or more via distance education or electronic delivery.

College of the Sequoias: to move classes and the Public Safety Training Programs (Fire and Police) from Visalia to the Hanford Education Center.

College of the Siskiyous: to add an LVN-RN program and relocate the nursing program to the Yreka campus.

Folsom Lake College: to offer seven programs at 50% or more via distance education or electronic delivery.

Mt. San Jacinto College: to 1) add a new location in West Temecula called the Temecula Education Complex, and) to offer two Associate degrees and nine certificate programs at 50% or more via distance education or electronic delivery.

MTI College: to change the status of the Cosmetology program from credit hour to clock hour.

Porterville College: to offer a new Associate Degree in Nursing.

Reedley College: to offer General Education, Business Administration, Information Systems, and Small Business Administration courses at 50% or more via distance education or electronic delivery.

Sacramento City College: to add a new location in West Sacramento called the West Sacramento Center.

San Joaquin Valley College: for an address change of the Temecula Geographical Area Location.

Windward Community College: to offer an Associate in Liberal Arts at 50% or more via distance education or electronic delivery.
