

I made the mistake of not reaching out to my counselor for options before the semester was over. I was going through different emotions and didn't even think about reaching out to anyone. Being a first-generation college student has been a challenge as I am still navigating the college system and understanding the processes. Now as a first-time mom, I am more motivated to continue going to school because I want to be able to provide for my son. Moving forward, I plan to only take two on campus courses per semester. I plan to take school more seriously and reach out to my counselor if I ever find myself struggling again. I ask that you please approve my petition as I know that I can do better next semester. I am currently not working since I have to take care of my child and my mother is willing to help during my class time. 



This was something I meant to do after my first meeting with my counter, this was a personal statement for financial aid as well. My counselor said it would be a good idea to see if I could be withdrawn from those classes because of what was happening.

The start of my freshman year at Taft College started off great, I put my all into passing my classes and ending my first year well but things for me went downhill during the last semester and summer. My relationship at home with my mother wasn't great. It really took a toll on my mental health. I understood that she was having problems with my brother's father along with money problems, but in the end, her frustration ended up being taken on me. She would shut off the wifi and even take the box with her even when she knew I had online classwork to do. Of course, I know I could have gone to the college library but that wasn't an option for me, she forbade me from leaving the house and if I did, things wouldn't end up good for me. She would go as far as to cut off my phone too. She's a very traditional Hispanic mom so I grew up in a strict household and going against her words was never a good thing. During those months it was only constant yelling and arguing, doors being slammed, and crying endlessly every

day only to have to repeat it all again the next day, there was no chance in between those times to focus on my school work when my mental health wasn't at it's best. It was truly one of the darkest times of my life. One that is not my proudest moment, where my thoughts were all over the place and made me feel like I was drowning and had no way out. To me everything seemed to be crashing down on me at once, adding to all that I'm also a first-generation college student in my household, and the pressure of it makes me nauseous when my mother would bring it up in arguments. There was even a time when I managed to go to my friend's house to get away for the night but they witnessed how horrible things were at home when I received messages with things I never want to listen to again, words that they saw made me break down into a crying mess. Things didn't return to normal till the end of summer and even then the damage had been done. In the end, I understand she has trauma from her own experience with her family, I don't like being the one who gets the yelling and words that cause me great pain but I'll take it all as long as it keeps my siblings from being the ones. Everything has smoothed out as of right now, I'm in a better mental state.


